# CAR RIDER AGREEMENT



Children coming to school late are a distraction to the learning process for all students, teachers and staff. In addition, children leaving school early are a distraction as well. Please try to schedule extra curricular activities, trips, doctor appointments, etc... after school has ended, so as not to interfere with the learning process.

- ✓ I agree to follow the carline procedures.
- ✓ I agree to pick my child up at the designated DISMISSAL time. Repeated failures to do so will result in the requirement that my child ride the bus home in the afternoons.
- ✓ I understand that I am responsible for getting my child **to school ON TIME**. I understand that if my child is tardy **more than 10 times** in a school year the follow actions must take place:
  1. My child will be switched to bus transportation, to and from school for the remainder of the year.
  2. Bus transportation for my child will be **mandatory for the next school year**.
  3. My child's transfer to Porter will be revoked if he/she does not ride the bus.

# BUS RIDER AGREEMENT



Riding on a PWCS school bus is a privilege, and rules are established to ensure the safety of all children riding the school bus. PWCS Bus transportation rules are listed in the Code of Behavior; please read and discuss these rules with your child. All students need to be aware of the bus rules.

- ✓ I will wait for my child's bus in the morning and meet my child's bus in the afternoon at his/her assigned bus stop unless I arrange for a responsible person identified above by name and telephone number to do the same.
- ✓ If my child is not met by his/her designated responsible person, the child will be returned to school and the parent/guardian will be responsible for picking up the child at Porter.
- ✓ I will instill in my child that he/she will not exit the bus at the bus stop unless the parent(s) or responsible person is present.
- ✓ I understand that repeated failures to meet my child at the bus stop will result in termination of my child's bus transportation privileges and/or his/her transfer to Porter being revoked.
- ✓ I understand that **ONLY** the individuals listed on this form will be allowed to pick up my child from the bus stop.
